Privacy Statement and Consent Form

Discovery World Corporation (the "Company") is the subject of the present document and explains how or what information about you or your transactions will be processed by them. Such information may include the name and address of an individual and their basic contact information as well as the more sensitive and private details of an individual such as their age, marital status, tax identification, records of government identification, financial records, and tax records, etc. (all hereinafter known as your 'Personal Information').

The Company may process your Personal Information for purposes of:

The Company strictly enforces its Data Privacy Policy and has implemented technological, organizational, and physical security measures to protect the information it holds from loss, misuse, modification, unauthorized or accidental access or disclosure, alteration, or destruction by:

- i. keeping and protecting your personal data using secured servers behind a firewall, deploying encryption on computing devices and physical security controls.
- ii. restricting access to your personal data only to qualified and authorized personnel who hold your personal data with strict confidentiality.
- iii. any personal data that you provide is processed and stored by the Company using a secured connection, only authorized company personnel can then access and download your personal data from the system.

To "process" means any action done on your Personal Information including collection, storage, transmission, use, disclosure, reporting, and disposal of your Personal Information.

The Company may share or disclose your Personal Information to:

- i. Any agent, contractor, or sub-contractor of the Company performing services related to inquiry or request;
- ii. Any consultant, adviser, auditor, or service provider engaged by the Company to carry out functions or activities related to its legitimate business activities;
- iii. Any court of law or administrative agency of the government pursuant to a lawful order issued in relation to a pending case or proceeding before such court or agency;
- iv. Any regulatory, quasi-judicial or judicial authority, or as otherwise considered necessary or appropriate by the Company for its legitimate business purposes.

The Company honors and abide to the following rights of the data subject:

- a. The right to be informed about the collection, use, and disclosure of your personal data;
- b. The right to access your personal data;
- c. The right to rectify any errors in your personal data;
- d. The right to erase or block your personal data
- e. The right to object to the processing of your personal data
- f. The right to data portability
